## 21//00297 - Westwinds, Mattocks Lane, Hedon

Application Type: Full Planning Permission – Erection of a two storey extension to side and single storey extension to rear

Resolved:

that the Committee supported the application subject to there being no substantive objections from neighbours; with a condition attached that the house remain as a single dwelling

## 21/00806 - Souttergate House, 59 Souttergate, Hedon

Application Type: Tree Works in a Conservation Area – Remove 1 no Cherry tree (1) due to tree suffering from fungal growth, is overhanging the boundary causing concerns to neighbours and is weakened at the base; Crown reduce 1 no Cherry tree (2) by cutting the crown back to the boundary due to branches overhanging neighbouring property

# 20/03558 - Merrywick Hall, 41 New Road, Hedon

Cllr Goldspink declared a personal interest as she lives close to the site; she took no part in the discussion or vote. Cllr Dennis declared a personal interest.

Application Type: Full Planning Permission – Siting of cabin with access ramp for use as visiting area with infection control for Covid-19 to allow safe visits to residents of care home (retrospective)

Resolved:

that the Committee supported the application for the duration of the Covid pandemic, which the cabin had been constructed for according to the application, it should then be dismantled and removed; the Committee were also unhappy that the planning process had not been followed by the applicant which had resulted in a retrospective application

## 21/00663 - Hedon Post Office, 7 Market Place, Hedon

Cllr Dennis declared a personal interest as he knew the owner of the building (not the applicant).

Application Type: Full Planning Permission – Change of use of former post office (sui generis) to a mixed use as a delicatessen (A1 now(E)) and hot food carvery (formerly A5 now sui generis)

Cllr Dennis declared a personal interest as he knew the applicant.

Application Type: Tree Works in a Conservation Area – Fell Christmas tree (pine) because of movement in high winds and excessive shading and low amenity value

## 21/00802 - Church of St Mary and St Joseph, Baxtergate, Hedon

Application Type: Tree Works in a Conservation Area – Fell 1 no Conifer tree (T1) as tree has outgrown its position and is smothering neighbouring walnut tree; Pollard 1 no Elderberry tree (T2) at 1.8 metres; Crown reduce 1 no group of orchard trees (G1) by up to 2 metres from the tips and crown thin by 20% as trees have been neglected over previous years
