Type of Application - Works to Protected Trees Crown Reduce 1 no Sycamore tree (T368) by shortening 1 no bough by 2 metres to the east due to crack in fork; Crown lift 1 no Beech tree (T369) due to minor lateral side branches overhanging road; Crown reduce 1 no Whitebeam tree (T372) by reducing 1 no bough to the east by 2 metres and shape the remaining crown by 1 metre to address crown suppression; Fell 1 no service tree (T377) due to basal decay and shape neighbouring Sorbus tree (T376) to address crown suppression; reduce 1 no Sycamore tree (T379) by lowering the southern stem to the second lateral at 3 metres due to weak union; Fell 2 no Ash trees (T380 & T382) due to ash dieback disease; Fell 1 no Whitebeam tree (T381) due to basal decay; Fell 2 no spindley Ash trees at 4 metres to the south; Fell 2 no Silver Birch trees (T451 & 453) to favour T450 and T452; Fell 1 no Ash tree at 0.5 metres in front of T454 due to tree being sapling in close proximity to T454
